# Data Sharing License Agreement

This Agreement states the terms under which

Linköping University through its Center for Medical Image Science and Visualization (CMIV) ("the Facilitator") with address CMIV, Universitetssjukhuset, 581 85 Linköping, Sweden,

on behalf of Skånes Universitetssjukhus through its Department of Haematology, Oncology and Radiation Physics ("the Provider") with address Klinikgatan 5, 222 42, Lund, and as regulated in a separate Data Transfer Agreement between the Provider and the Facilitator,

will non-exclusively make available the dataset doi:10.23698/aida/lund-probe (the "Dataset")

## §1. Use of the Dataset

The Dataset can be used for any purpose, under the control of the Recipient Scientist, and related to medical imaging. However, the Dataset cannot be used as part of direct patient care. The Recipient Scientist undertakes to retain control over the Dataset at all times, and not to give any third party access to the Dataset without the Facilitator's prior written approval. In addition to that, the Recipient Scientist must not re-identify or attempt to contact participants. The data must not be re-distributed to anyone, even within the own group of the Recipient Scientist, and especially not online or in any other format.

The Dataset is provided "as is". The Dataset is provided as a service to the research community. THE DATASET ARE BEING SUPPLIED TO RECIPIENT SCIENTIST WITH NO WARRANTIES EITHER EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS, OR THAT THE DATASET CAN BE USED WITHOUT RISK. The Facilitator makes no representations that the use of the Dataset will not infringe any patent or proprietary rights of third parties.

In no event shall the Provider or the Facilitator be liable for any use by Recipient Scientist of the Dataset or any loss, claim, damage or liability which may arise from or in connection with this agreement or the use of the characteristics of, handling, storage or transportation of the Dataset. Recipient Scientist shall indemnify and hold harmless the Facilitator and any of its employees from and against any loss,
